President's Message

At Aqua Illinois, we continue to partner with diverse suppliers to enhance business performance, maintain a supplier base that is reflective of our customer base, and assist in promoting a vibrant local economy. We take pride in our efforts and are gratified by the success of our many diverse suppliers.

In 2023, Aqua Illinois took some additional steps to grow our diverse supplier base and further promote the use of Tier II diverse suppliers where diverse prime contractors may not be readily available. In March of 2023, we held an in-person event with both existing and prospective diverse suppliers focused on helping to not only identify new diverse suppliers, but to also help new diverse suppliers understand how the process works in order to create the most effective and efficient working relationships.

To promote Tier II diverse spend, we added language on prime construction contracts that encourages non-diverse primes to partner with diverse subcontractors. This combined with the supplier diversity event mentioned above, resulted in our ability to expand our base of diverse suppliers by 24.8%. Additionally, our Tier II spend was 14 times more than the previous year, due in large part to the new contract language.

Aqua Illinois was also able to increase diverse spend on Professional Services in 2023. This intentional use of diverse professional firms has resulted in a more meaningful and enhanced customer experience.

At the same time, 2023 was not without challenges. While our overall spend increased, our diverse spend pace remained the same and significant MBE lags other diverse categories. A key driver was the lack of diverse suppliers for specific chemicals and some capital equipment procured in connection with large construction projects.

Aqua Illinois remains committed to supplier diversity and continues to develop strategies to address challenges and expand overall use of diverse suppliers in order to support how our local economies grow and thrive.

I am pleased with the steps we have taken this year and invite you to follow our progress in this report.





NUMBER OF EMPLOYEES - 143 (includes Aqua contact center, located in IL)






Terms and Definitions

For purposes of this report, we are including (SBE) small business enterprise, which is a business that is defined by either the number of employees or average annual receipts of a business concern.

Aqua only recognizes and uses suppliers that are certified as diverse—MBE, WBE, or VBE.







Policies and Methodology

At Aqua, the core values of integrity, respect, and excellence are embedded within our business practices and our behavior. We proudly hold ourselves accountable to fair and transparent business practices and strive to operate as a socially responsible corporate citizen. We also expect our suppliers and contractors to demonstrate the same commitment to these values.

We recognize that Supplier Diversity is significantly important to our long-term procurement and supply chain process strategy. We have strategies in place to further build and enhance relationships with more diverse suppliers, and encourage them to compete for materials and services throughout all of Aqua. It is the policy of Aqua to develop significant partnering relationships with diverse firms to:

- Enhance the supply chain via lower costs, increased response time, higher level of quality, etc.
- Provide a competitive advantage in building brand equity and retaining existing or generating increased market share.

Additionally, all employees with spending authority are encouraged to consider diverse businesses as Tier I suppliers and to encourage Aqua's prime suppliers to do the same. Aqua encourages any certified diverse supplier that may have services of value to Aqua to apply as a supplier.

Aqua also submits an annual report of its diverse supplier spend to the Illinois Commerce Commission, which also tracks Aqua's Tier II spend dollar amount and percentage.

Aqua strongly encourages all of its prime suppliers to utilize diverse suppliers, as well as submit their diverse spend dollar amount and percentage (of Aqua project/contract) through Aqua's automated Tier II reporting tool, the Supplier IO UniTier Tier II Platform, on an annual basis, no later than January 31.

Supplier Diversity Goals

In 2023, Aqua held an in-person supplier diversity event that included both existing diverse suppliers from across our state footprint as well as diverse firms looking to do business with Aqua. We discussed wanting to do more with existing suppliers and, via workshop with our existing diverse suppliers, provided information to prospective suppliers to help them better understand our processes. We also invited representatives from the Kankakee County NAACP to participate and to assist in helping Aqua identify other suppliers. The event helped to ensure we continuously enhance our policy to not only strengthen our ability to increase overall diverse spend, but also to identify new categories of goods and services that may create opportunities for additional diverse suppliers.

Since 2020, these efforts have directly resulted in many advancements made to the supplier diversity program, including:

- Increased VBE spend by 22.1%
- Increased building and grounds by 236.3% or \$384,400
- Increased direct materials by 163.3% or \$649,600
- Increase professional services by 115.2% or \$919,400

Aqua has also taken action internally to increase its work with diverse suppliers in the procurement process. This includes:

- Leadership commitment and accountability—demonstrating leadership commitment and accountability through messaging, policies, and behavior that advances diversity and inclusion goals and objectives.
- Promote business and community diversity—advancing diversity and inclusion in the Aqua supplier base by directing and supporting diverse suppliers, as well as supporting diverse groups through our charitable giving program.
- Regular review of vendor relationships—reviewing 12-month rolling spend of all vendor relationships exceeding a threshold of \$50,000 to identify opportunities to solicit bids from diverse vendors as services are renewed.

Maximizing successes from the previous year, which included a successful supplier diversity event, increased Tier II and professional services spending, and expansion of the overall supplier base, supplier diversity goals for 2024 include:

- Continue to promote the use of Tier II diverse suppliers with our non-diverse prime contractors
- Work with other IUBDC member utilities to leverage best practices
- Focus on identifying diverse capital equipment manufacturers/dealers to increase spending in this category
