President's Message

In 2020, Aqua's parent company, Essential Utilities, Inc., became one of the largest publicly traded water, wastewater, and natural gas providers in the U.S., serving approximately 5 million people across 10 states under the Aqua and Peoples brands. With a combined 250 years of operating experience and a shared commitment to rebuilding the nation's aging infrastructure, Essential also values diversity and inclusion within its workplace and with its relationships with contractors and suppliers.

At Aqua Illinois, this has strengthened our ability to partner with local vendors in the communities we serve and further establish and grow partnerships with diverse contractors and suppliers that have enhanced the supply chain and supported local economies.



This has had a direct impact on our ability to provide high-quality water and reliable service to our customers every day. While there is more to do, I am proud to report that we have met our 2020 goals resulting in substantial enhancements to our diversity policy and programs. Of the \$41 million total eligible spend, I am pleased to report that \$6.3 million or 15.5% was diverse spend and \$3.4 million or 8.4% was small business (SBE) for a total reportable spend of \$9.8 million.

Expanding our supplier diversity program has resulted in cost efficiencies through healthy competition—53 diverse suppliers and 9 new suppliers. These partnerships have further supported our commitment to provide quality water and reliable service to our customers.

At Aqua, we believe that our customers' communities are our communities, too. Creating and fostering a diverse environment where all are represented makes us a stronger socially responsible corporate citizen. I invite you to follow our 2020 accomplishments and continued progress in this report.





NUMBER OF EMPLOYEES - 142 (includes Aqua call center, located in IL)






Terms and Definitions

For purposes of this report, we are including (SBE) small business enterprise, which is a business that is defined by either the number of employees or average annual receipts of a business concern.

Aqua only recognizes and uses suppliers that are certified as diverse—MBE, WBE, or VBE.





Policies and Methodology

At Aqua, the principles of integrity, respect, and excellence are embedded within our business practice and our behavior. We proudly hold ourselves accountable to fair and transparent business practices and strive to operate as a socially responsible corporate citizen. We also expect our suppliers and contractors to demonstrate the same commitment to these values.

We recognize that Supplier Diversity is significantly important to our long-term procurement and supply chain process strategy. We have strategies in place to further build and enhance relationships with more diverse suppliers and encourage them to compete for materials and services throughout all of Aqua. It is the policy of Aqua to develop significant partnering relationships with diverse firms to:

- Enhance the supply chain via lower costs, increased response time, higher level of quality, etc.
- Provide a competitive advantage in building brand equity and retaining existing or generating increased market share.

Additionally, all employees with spending authority are encouraged to consider diverse businesses as Tier I suppliers, and to encourage Aqua's prime suppliers to do the same. Aqua encourages any certified diverse supplier who may have services of value to Aqua to apply as a supplier.

Aqua also submits an annual report of their diverse supplier spend to the Illinois Commerce Commission, which also tracks Aqua's Tier II spend dollar amount and percentage.

Aqua strongly encourages all of their prime suppliers to utilize diverse suppliers, as well as submit their diverse spend dollar amount and percentage (of Aqua project/contract) through Aqua's automated Tier II reporting tool, the Supplier IO UniTier Tier II Platform, on an annual basis, no later than January 31st.



Supplier Diversity Goals


Aqua continues to work with a supplier diversity consultant, Diversity Sourcing Solutions, to help identify and vet qualified diverse suppliers. That means enhancing our policy to not only strengthen our ability to increase overall diverse spend, but also to identify new categories of goods and services that may create opportunities for additional diverse suppliers.

Since 2019, these efforts have directly resulted in many advancements made to the supplier diversity program, including:

- Increased Diverse Spend to \$6.3M or 15.5% of Total Eligible Spend of \$41.1M
- Increased Reportable Spend (MBE, VBE, WBE, SBE) by 60% or \$3.67M
- Increased Tier II Spend by 171%
- Increased WBE spend by 15% nearly \$3.3M
- Increased VBE by 165%
- Increased SBE by 186%
- Increased Technical Services by 24%, including SBE
- Construction continues to be our biggest category of Reportable Spend at \$7M, an increase of 122% or \$3.85M, including SBE
- · Held statewide virtual supplier diversity workshop and follow up individual meet and greets
- Implemented Essential's diverse supplier onboarding assistance initiative
- Implemented UniTier Tier II reporting

Aqua has also taken action internally to increase its work with diverse suppliers in the procurement process. This includes:

- Updating its internal purchasing website to include our Supplier Diversity Policy, which establishes guidelines for buyers to follow regarding the use of diverse suppliers, advises buyers of their role and responsibility to support the program by contracting with diverse suppliers or including them in Request for Proposals whenever possible.
- Promoting the use of diverse suppliers in its Supplier Code of Conduct
- Regular review of purchase requisitions to expand the use of diverse vendors





Areas of Procurement for the Next Calendar Year


In 2021, Aqua Illinois has committed to exceeding our 2020 diverse spend. This goal is supported by category managers' creation of a Supplier Diversity Operating Plan and commitment to a spend target in all categories (MBEs, WBEs, and SBEs).

In the supplier selection/bid evaluation process, Aqua considers not only price effectiveness, competitive nature, and service, but also diverse suppliers in order to meet its goals. Buyers are encouraged to search for opportunities to use diverse suppliers whenever possible.

In 2021, Aqua's parent company Essential Utilities, Inc. joined the National Minority Supplier Development Council (NMSDC) to further help Aqua Illinois identify and partner with minority-owned businesses. In addition, Aqua began tracking ethnicity to further enhance its reporting capabilities.

Additional goals for supplier diversity in 2021 include:

- Increase professional and technical services category spend
- Enhance Agua's WBE, MBE, and VBE program and policies
- Implement a new supplier diversity dashboard for real-time reporting and tracking
- Increase minority spend by identifying current and new opportunities
- Standardize minority supplier process and protocols across all functions
- Further enhance diversity philosophy and culture throughout the organization
- Conduct in-person/virtual outreach events in all three regions Aqua serves in Illinois



Challenges and Opportunities

Aqua Illinois continues to identify new opportunities to expand its diversity spend and increase the number of diverse suppliers available in its pool of potential contractors.

Aqua has identified potential diverse suppliers in a number of categories. Once the suppliers are vetted, several will be invited to present their capabilities:

- Technical Services
- Professional Services
- Water Chemicals
- Engineering Services
- Legal
- Treasury
- Testing Laboratories
- Wastewater Residuals Management

Other efforts to identify diverse suppliers include plans for a Supplier Diversity Workshop with our prime suppliers to connect them with MBEs, WBEs, VBEs, as well as utilizing the Supplier IO database of 1.5 million suppliers. Aqua is also working with local resource and regional partner organizations to identify additional qualified certified suppliers. We also continue to connect with and develop relationships with SBE suppliers.




